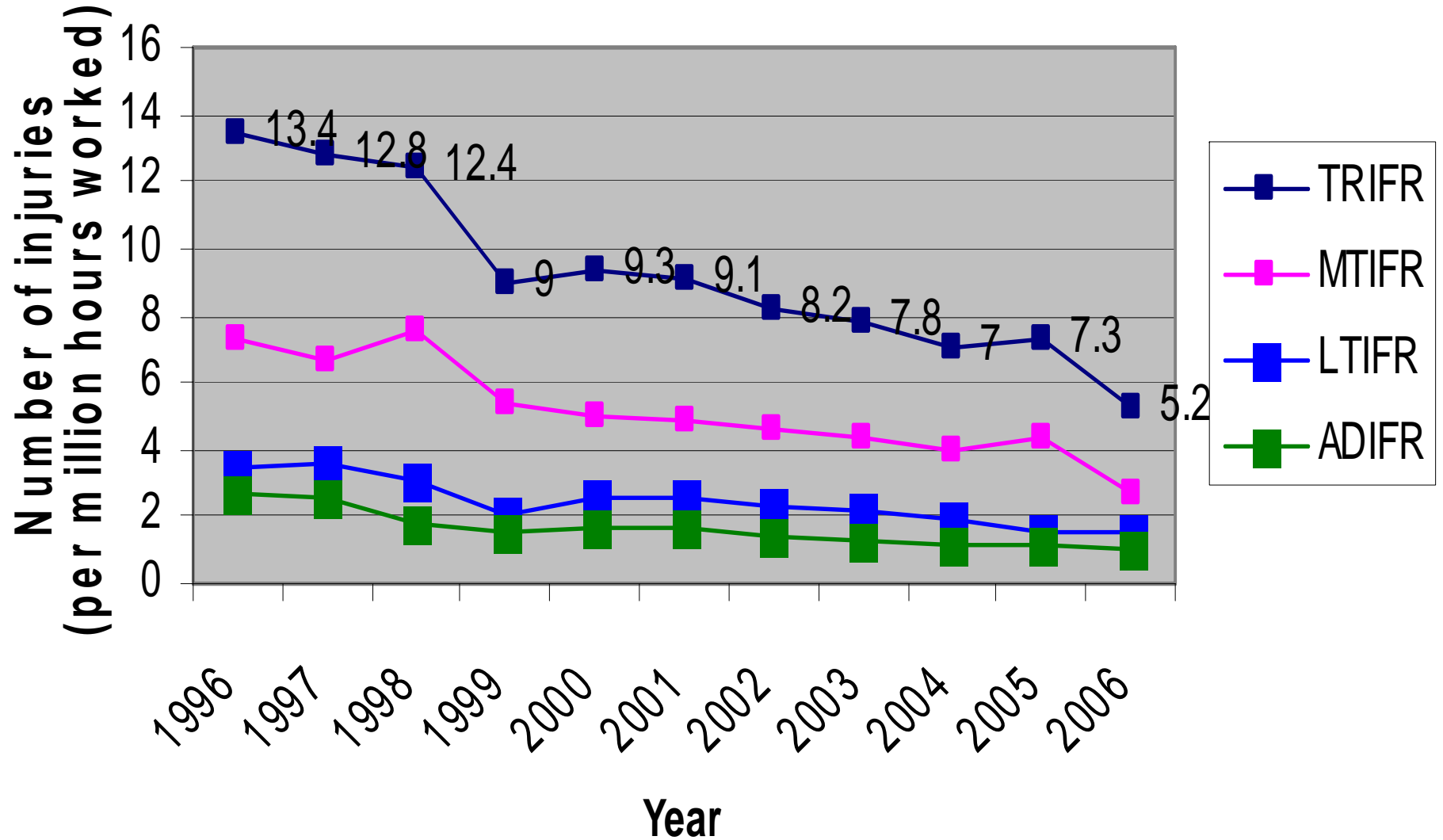

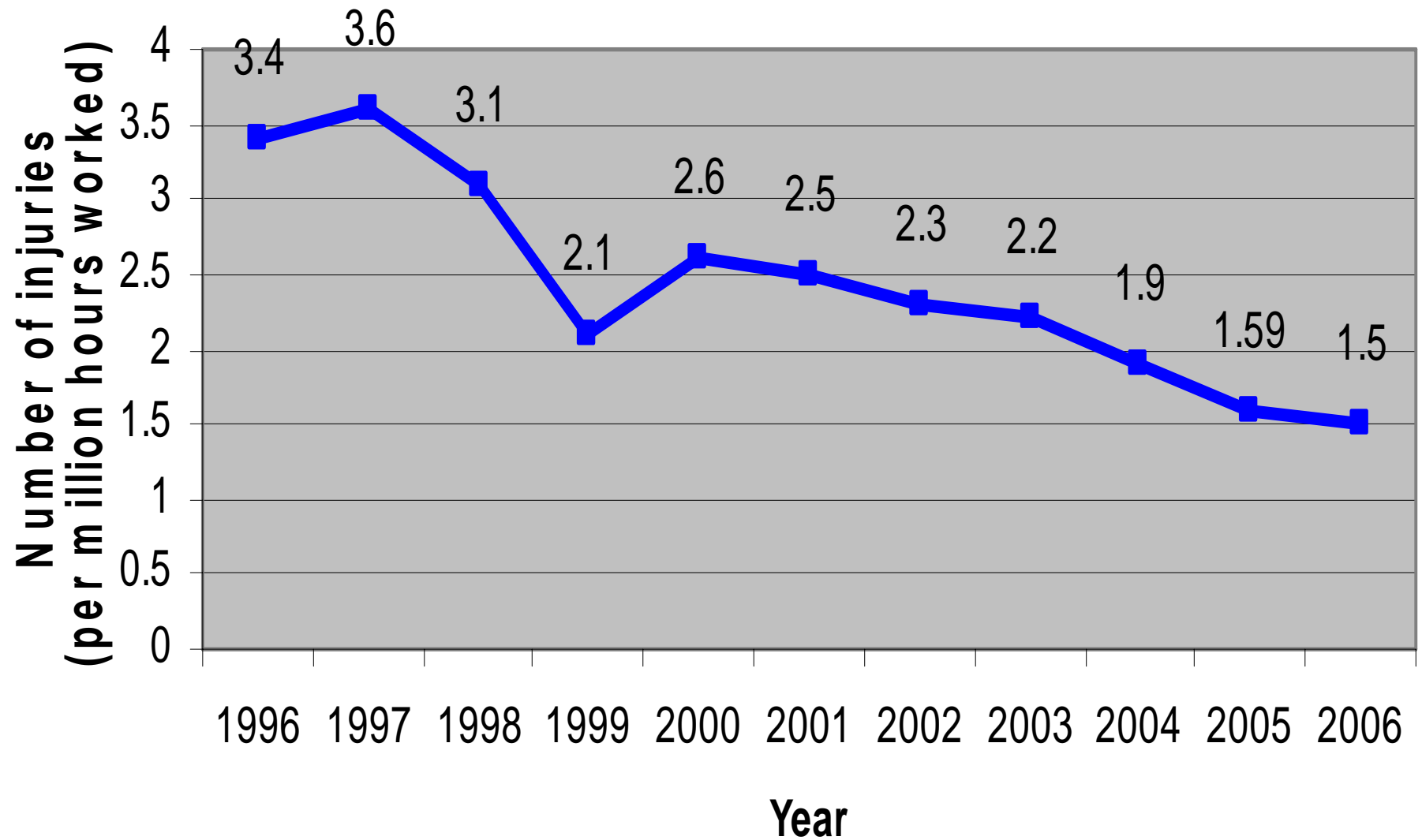

Injury Frequency Rates 1996 - 2006



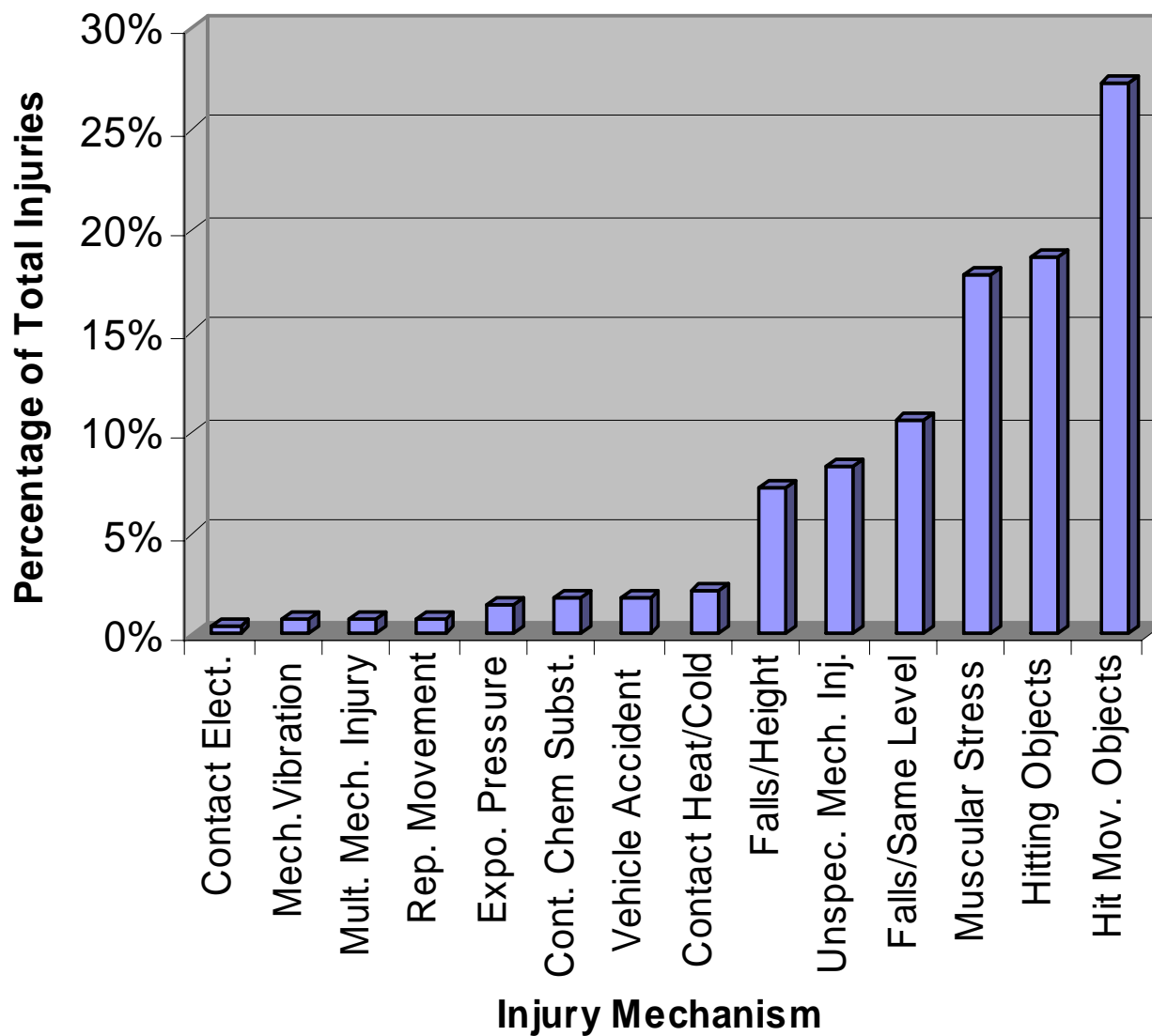
Lost Time Injury Frequency Rates 1996 - 2006



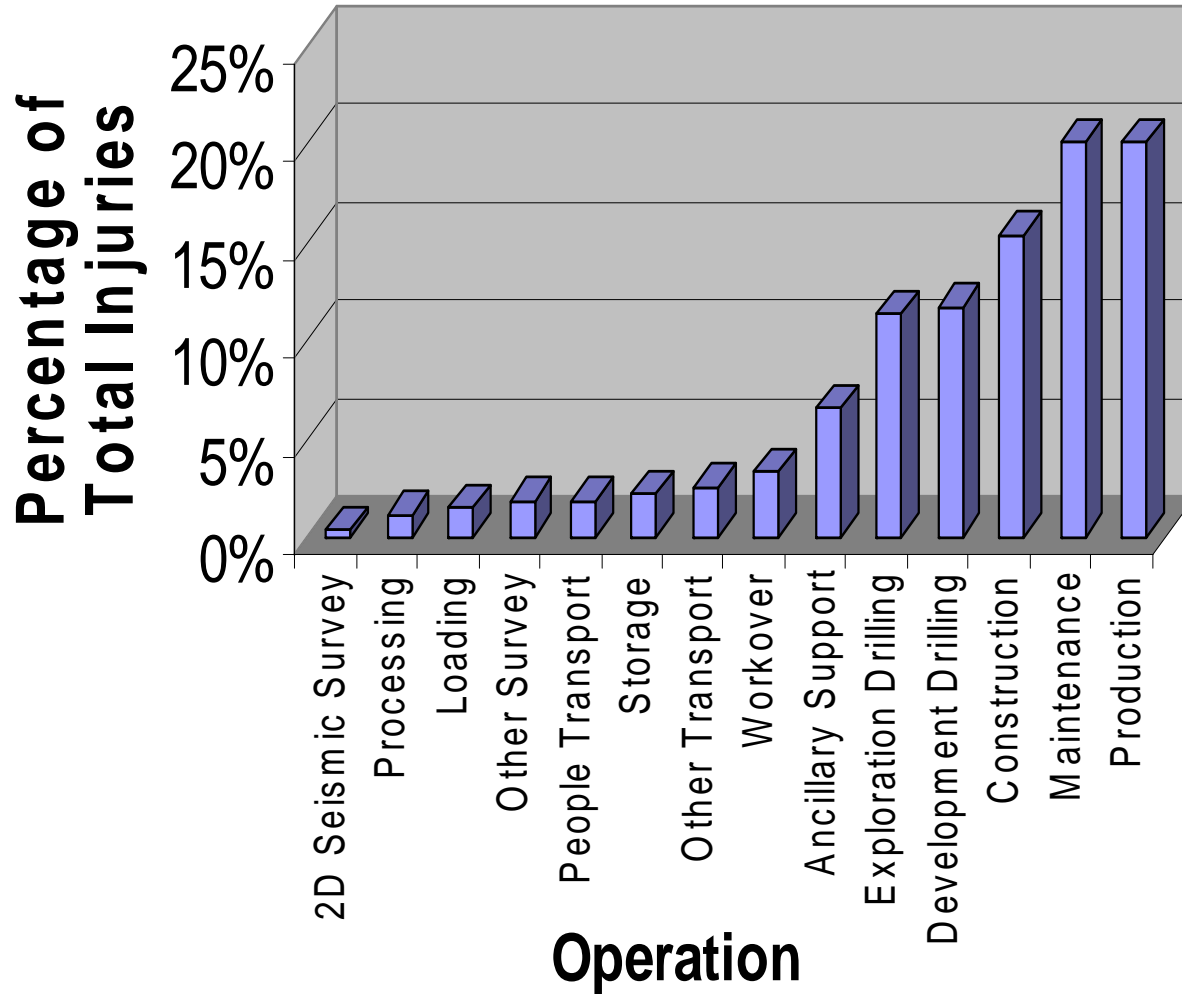
International Lost Time Injury Frequency Rates 2005



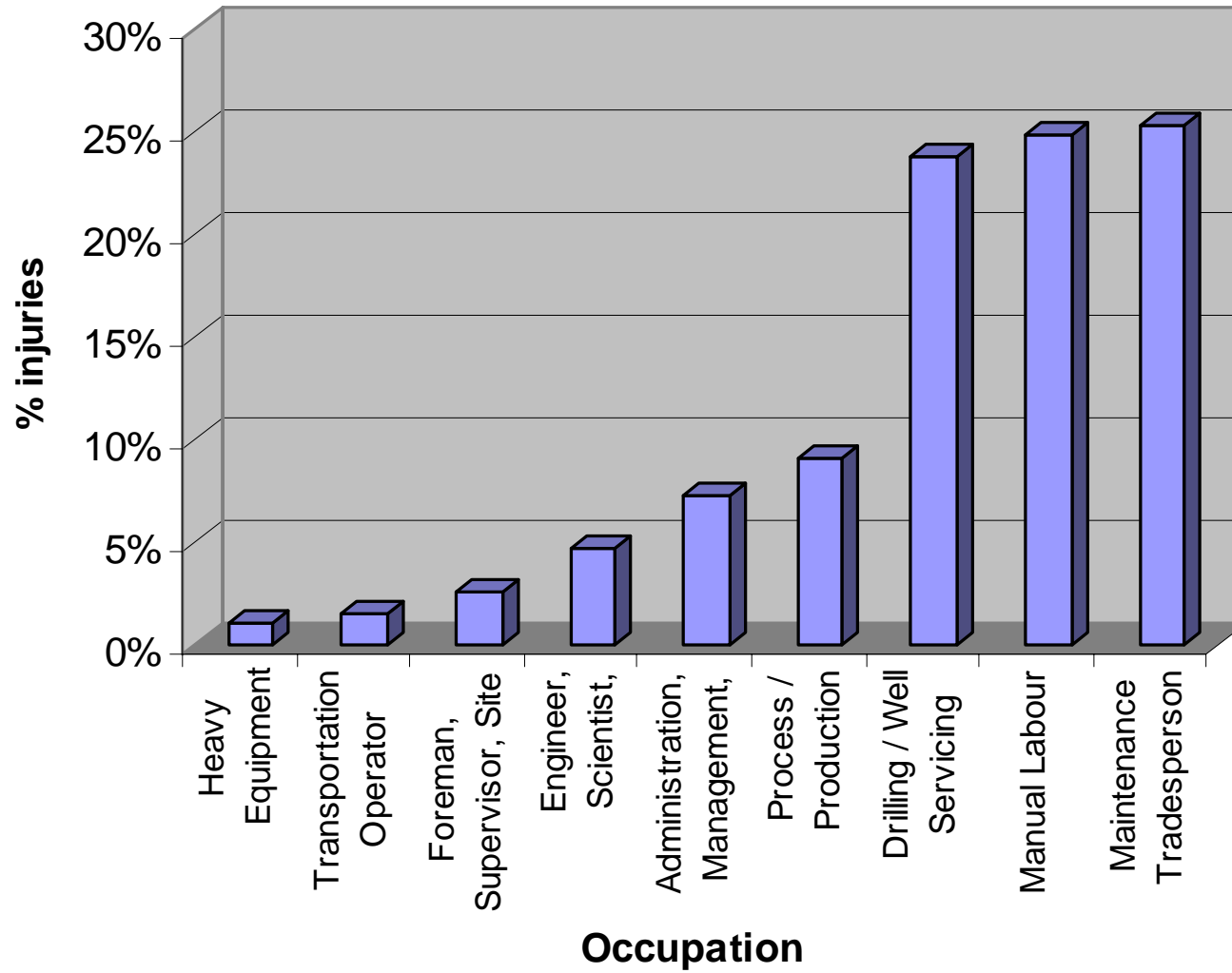
2006 Injury Mechanism % (Total = 274)



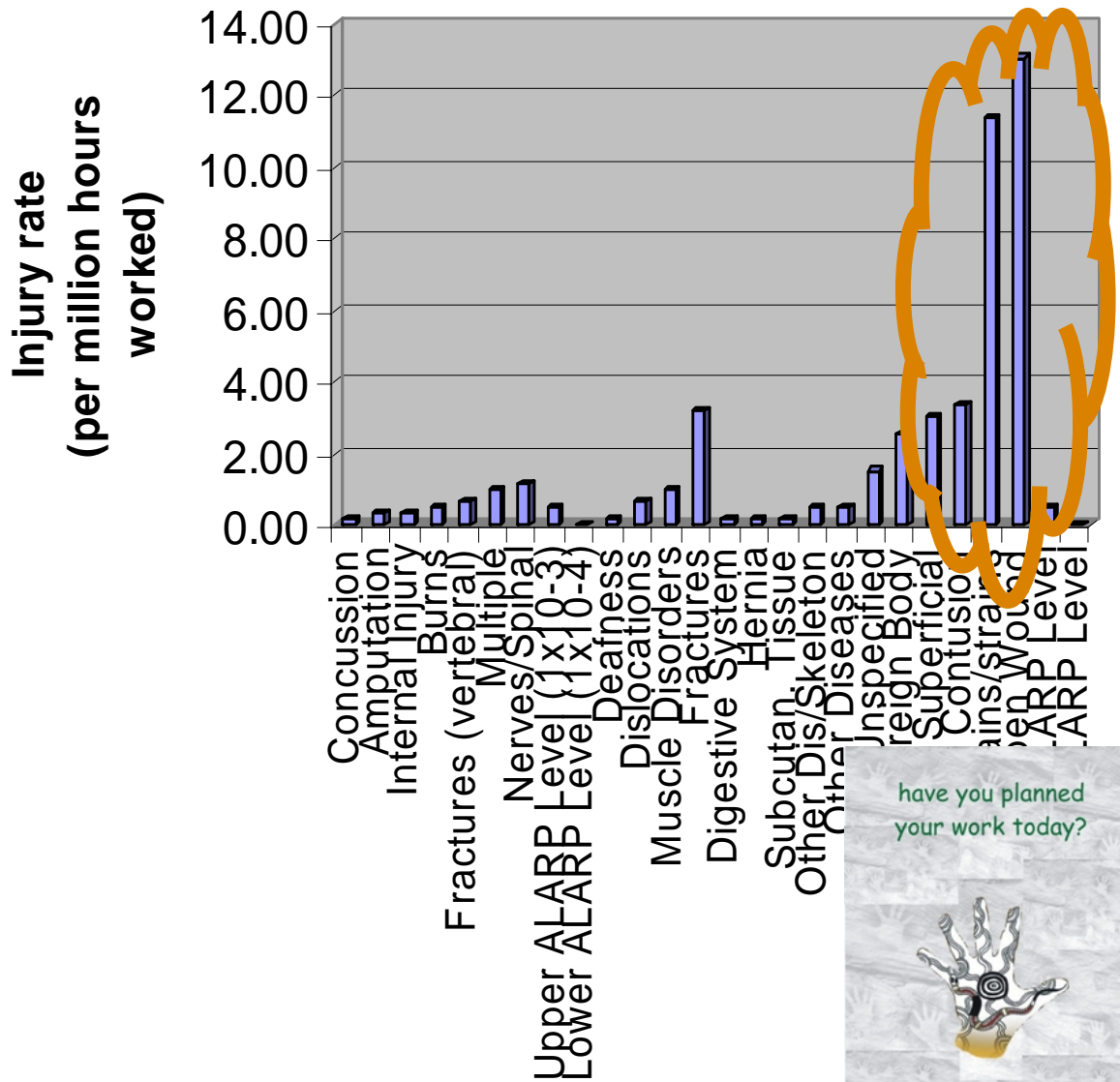
Injuries by Operation (Total = 273)



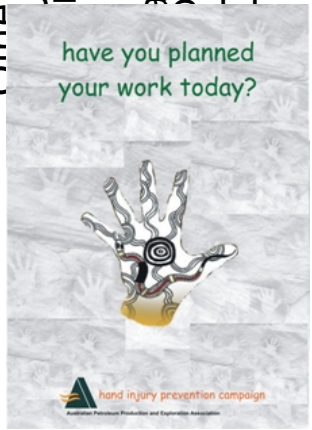
2006 Injuries by Occupation (Total = 277)



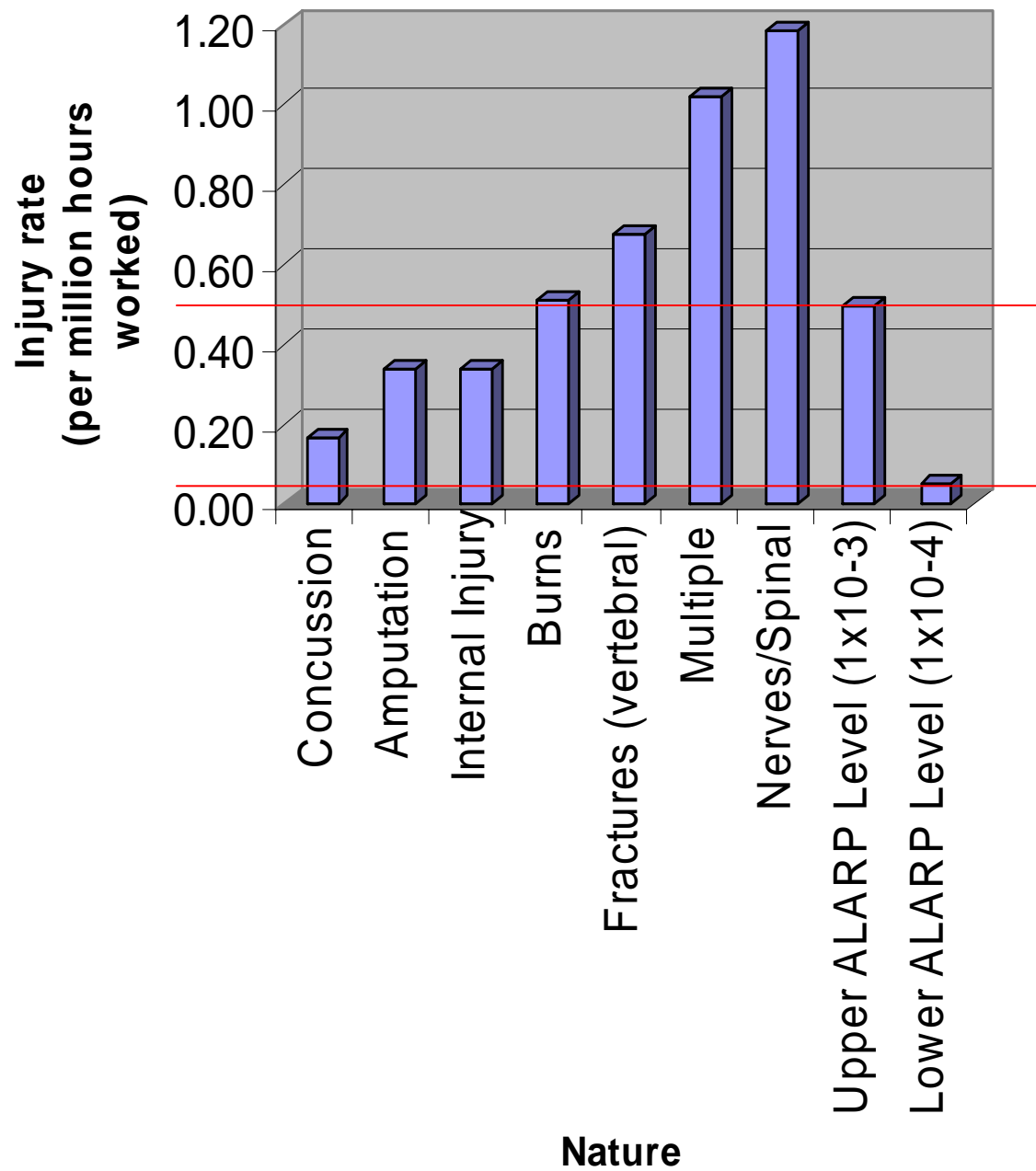
Nature of injuries 2006



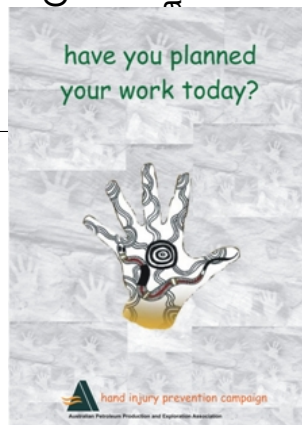
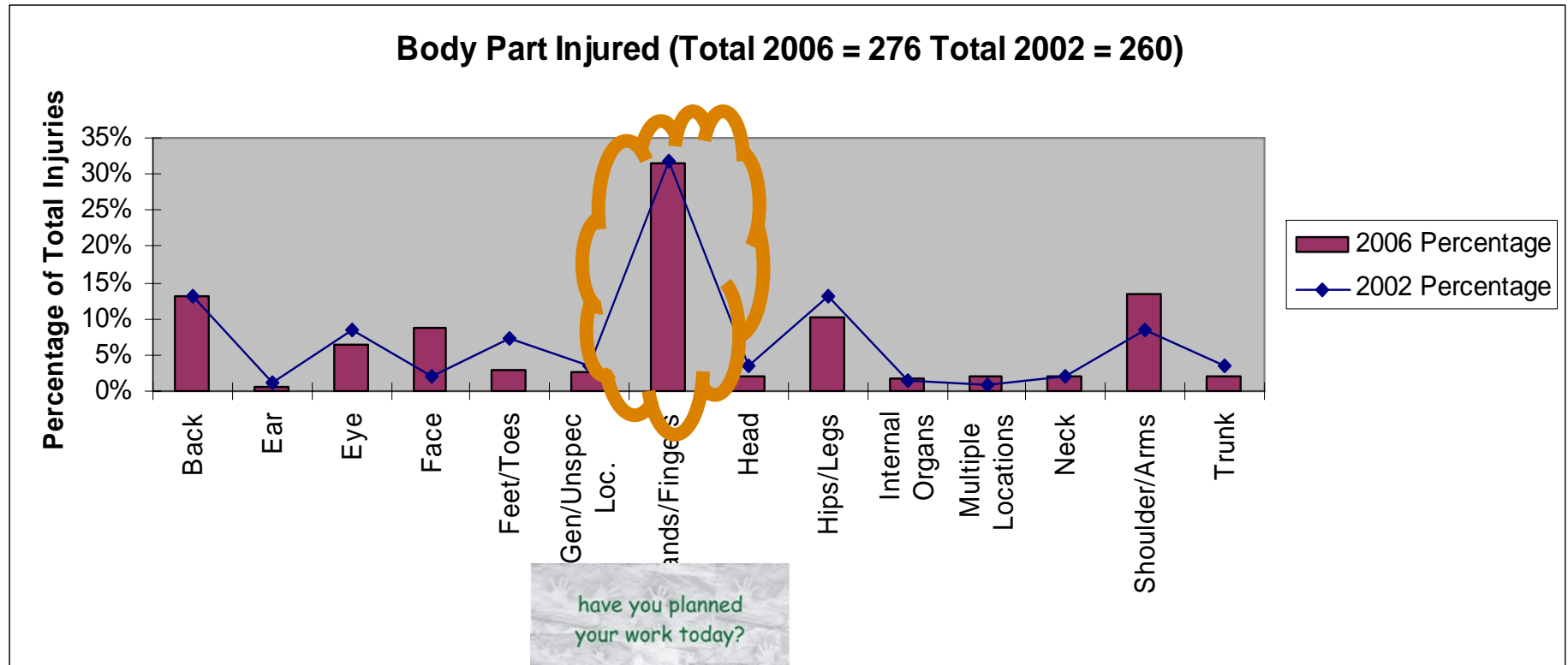

- Session 5 - correct hand care including daily hygiene practices, care of wounds including basic first aid for hands (3 mins)

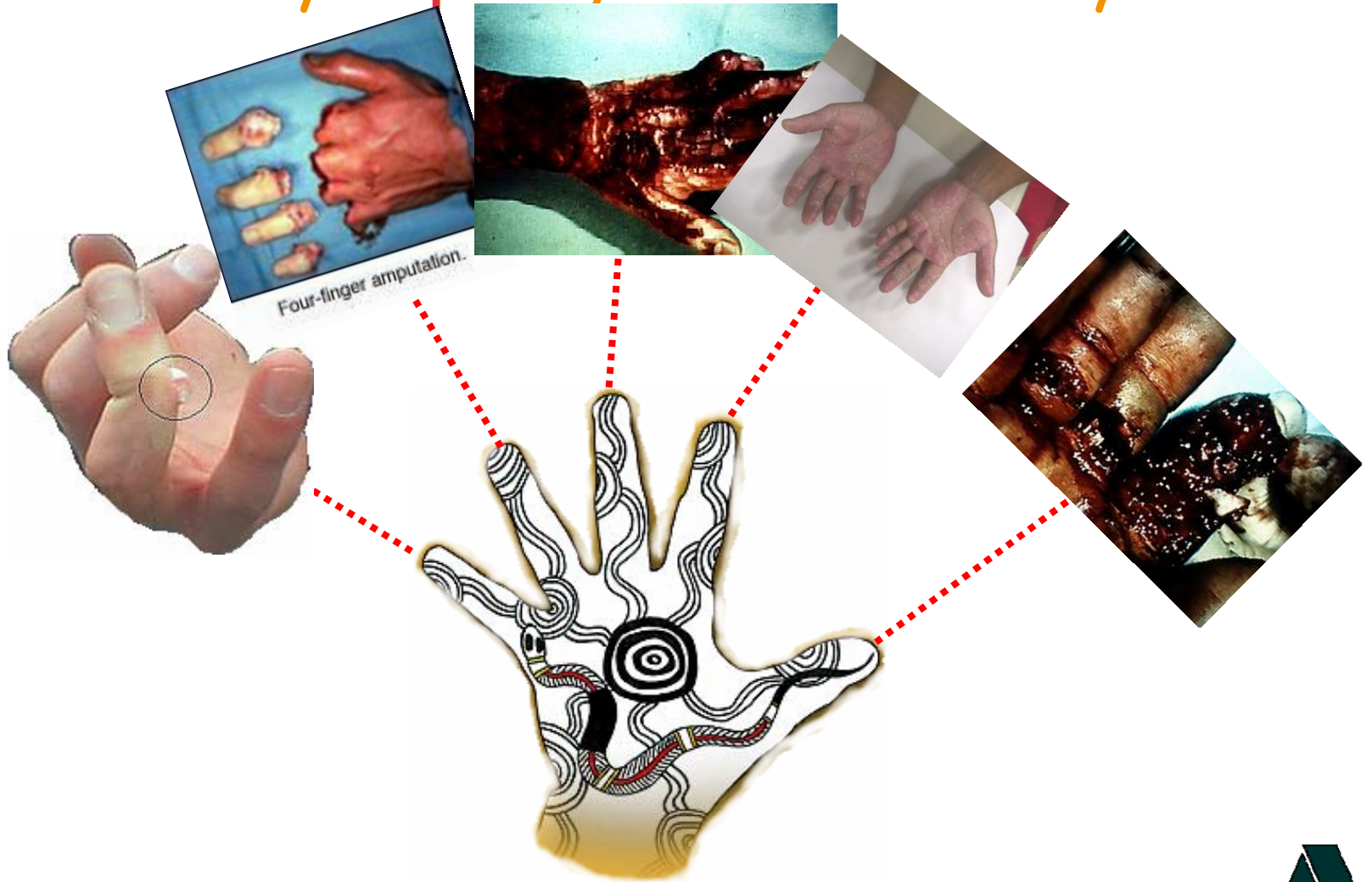

 - Safety Leadership Forum APPEA Council and industry leaders, while providing a forum through which industry leaders, regulators, policy makers and the workforce can discuss and drive improvements to safety performance



What is APPEA Considering Doing?

- Developing common Induction Training and Behaviour Based Safety Training programmes
- Undertaking an industry wide Safety Culture survey
- Facilitating the establishment of a Postgraduate education programme for Safety professionals
- Facilitating the establishment of simulation training for Offshore Crane Operators
- Undertaking research into National differences in safety culture and risk perception
