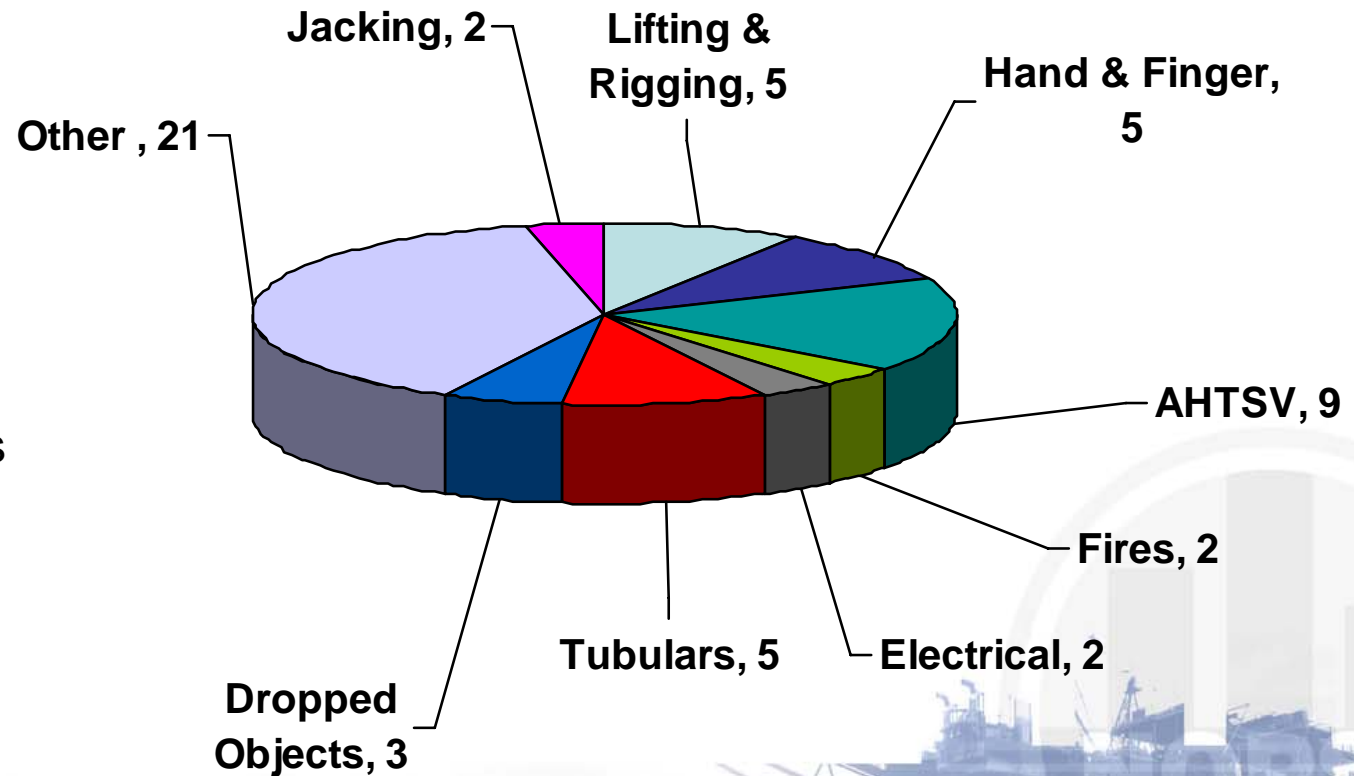
- Industry challenge

# Perspective on 2006 Incidents

54 reported incidents,  
Many single, but serious, incidents



# Perspective on 2006

## Incidents

- **Most significant incidents**  
Interaction with established facilities  
Cyclone down-manning
- **Most common failing**  
Not using SMS tools properly..JSA, PTW, etc.



# Perspective on 2006

## Complaints

---

- **Statistics –**  
10 Complaints about 6 issues on 3 facilities
- **Most significant complaints**  
Work environment – welfare issues
- **Outcomes –**  
1 Ministerial, 1 dealt with thru inspection, 2 investigations, 1 referral to other agency

# Perspective on 2006 Enforcement

- **Warning Letters - 12**  
Wide range of topics – following inspections and investigations
- **Improvement Notices - 13**  
Noise – (prescriptive issue), firewater pumps, safety training, safe place of work
- **Prosecutions**  
1 Brief lodged – 2 pending



# Perspective on 2006

## “Regulatory” performance

---

- **SC Preparation**
  - Evolution of roles and responsibilities between contractors and clients
  - Improving quality and variety of submissions
- **SC Assessment**
  - Still getting some poor quality SC
  - Still getting requests for “fast-track” assessments
