History of DrillSafe

- Started in 1996 by BHP with their direct contractors.
- BHP invited their JVPs and then other key operators in Perth.
- By 1997/98 it had expanded to include all operators, contractors, regulators.
- Renamed as DrillSafe circa 2000.

The key to Drillsafe's sustainability

- Committee with “stroke” in their own organisations
- Free entry due to sponsorship support
- Networking opportunity – drinks, breaks etc.
- Mature industry prepared to present their shortcomings warts and all
- Relevant topics – local incidents and initiatives
- Keep it simple – no working groups / no work expectation
- Senior company representation at forums
- Presented in key operating areas (annually 2 x Perth, 2 x interstate)
- Non commercial.... no sales pitches
- Can opt out and come back in...it keeps rolling



Success Stories

- Joint Operator Auditing Program (HSEQ).
- Joint training initiative.
- Hands off loads initiative.
- Uptake of aero medivac...eg. Aspen Jet
- Rationalising HUET training & duration (TBOSIET)
- Expanding minds – increased “Health” focus and initiatives offshore.



....and you never know what sharing prevented an incident that never happened.



What has not worked so well?

- Trend in corporate policies restricting contribution.
- Early efforts to create working groups failed
- Threats to website publishing. Press using it for negative information.
- Committee members without company empowerment.



A snapshot of 2010 forums
